

Privacy Policy

This Privacy Policy ("Policy") applies to <https://www.oneinnovative.net>, and One Innovative Management LLC ("Company") and governs data collection and usage. Collection of your Personal Information

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:
